- 1) Call to Order Ms. Thomson called the meeting to order at 10:05 a.m. and stated the meeting date and location.
- 2) Roll Call & Establishment of Quorum Ms. Cuadra called roll. Committee members Ms. Kathleen Thomson, Ms. Wendy Hatch, Mr. King Gee, and Mr. James Moore were present at meeting location 1747 N. Market Blvd, 1st Floor Hearing Room, Sacramento, CA 95834. Ms. Hang Le To was absent. A quorum was established with four members present.
- 3) Advisory Committee, Bureau Chief, Staff and Legal Counsel Introductions Committee Members, Bureau staff, and Legal Counsel introduced themselves.

Public Comment: A comment was made regarding the discrepancy between number of active licensees and the renewal fees collected according to the fund condition report. Another comment was made that more funding is needed for enforcement.

8) Legislative Update and Discussion -

Mr. Alexander Millington, DCA Legislative Affairs Analyst, read the remaining deadline dates for the 2019 legislative year, stated there were no bills directly related to the Bureau, and read the bills and status of each bill.

Committee members asked for clarification on AB 1396, AB 1378, and SB 496.

Public Comment: A comment was made that the Bureau should educate licensees on SB 303. Additionally, the synopsis of the bill is incorrect. A comment was made that the Professional Fiduciaries Association of California takes a neutral position on SB 303.

Professional Fiduciaries Bureau June 17, 2020 Legislative Update

Important Legislative Dates – Spring 2020

- June 5 Last day for fiscal committees to hear bills (Assembly only)
- June 15 Budget Bill must be passed by midnight
- June 19 Assembly begins Summer Recess
- June 19 Last day for fiscal committees to hear bills (Senate only)
- July 2 Senate begins Summer Recess
- July 13 Legislature reconvenes from Summer Recess

Please note, the Senate and the Assembly calendars will be synchronized once the Legislature returns from Summer Recess on July 13, 2020.

2020 Legislation Related to the Bureau

AB 1263 (Low) Contracts: consumer services: consumer complaints

This bill would prohibit contracting for, or to propose to contract for, an agreement to not file a complaint with a licensing board or to participate in a license board's investigation into a licensee for a consumer service.

May 2020 Status: In Senate, pending committee referral

AB 1396 (Obernolte) Protective orders: elder and dependent adults

This bill authorizes a court to order a restrained party who abused an elder or dependent adult ot attend clinical counseling or anger management courses.

May 2020 Status: This bill was chaptered on October 8, 2019.

AB 1616 (Low) Department of Consumer Affairs: boards: expunged convictions

This bill would require programs under the Department of Consumer Affairs (Department) that post information on their website regarding an individual's license being revoked due to a criminal conviction, to post notification of the expungement order for current licensees, or remove information about the revoked license within six months of the program receiving an expungement order related to the conviction for individuals that are not currently licensed.

May 2020 Status: In Senate, pending committee referral

AB 2430 (Nazarian) Professional fiduciaries: prelicensing and renewal or restoration: education

This bill would require professional fiduciaries licensees to have one hour of instruction in lesbian, gay, bisexual and transgender (LGBT+) cultural competency beginning January 1, 2022. **May 2020 Status:** Held, per the Assembly Appropriations Committee.

AB 2657 (Maienschein) Financial abuse of elder or dependent adults

This bill would allow Adult Protective Services to share relevant information with a federal law enforcement agency investigating a known, or suspected, case of elder or dependent adult abuse. The bill would also permit Adult Protective Services to share relevant information with a local

code enforcement agency investigating a property where the health and safety of an elder, or dependent adult resident, is at risk.

May 2020 Status: Pending in the Assembly Committee on Aging and Long-Term Care

SB 303 (Wieckowski) Guardians and conservators: compensation: residence of conservatee This bill imposes a higher standard for the sale of a conservatee's personal residence and limits the amount of compensation that may be paid to a guardian, conservator, or attorney from a ward's or conservatee's government benefits.

May 2020 Status: This bill was chaptered on October 12, 2019.

SB 338 (Hueso) Senior and disability victimization: law enforcement policies

This bill establishes the "Senior and Disability Justice Act" which requires a local law enforcement agency that adopts or amends its policy regarding senior and disability victimization after April 13, 2021, to include information and training on elder and dependent adult abuse.


May 2020 Status: This bill was chaptered on October 8, 2019.

SB 496 (Moorlach) Financial abuse of elder or dependent adults


This bill adds broker-dealers and investment advisors to the categories of persons who are mandated reporters of suspected abuse of an elder or dependent adult; allows mandated reporters who report suspected abuse to notify a trusted contact person previously designated by the elder or dependent adult for that purpose, as specified; and allows mandated reporters to temporarily delay requested account transactions and disbursements of elder or dependent adults, as specified.

May 2020 Status: This bill was chaptered on September 6, 2019.
