

22 The Court, having noted the appearance of Deputy Attorney General Michael Brown on
23 behalf of the Applicant Professional Fiduciaries Bureau, having read and considered the moving
24 papers, oral and written arguments, and having heard and considered any objections on behalf of
25 Defendant Donna Margaret Bogdanovich, finds that good cause supports the application of the
26 Applicant Professional Fiduciaries Bureau pursuant to Penal Code Section 23, and that under the
27 current circumstances it is appropriate to impose reasonable restrictions on Defendant, in the
